ASSIGNMENT OF TRADEMARKS (“**Assignment**”), effective as of January 14, 2020, from NFS Leasing, Inc., a Massachusetts corporation (the “**Assignor**”) to NFS CAP WEBBA, LLC, a Delaware limited liability company (“**Assignee**,” and together with the Assignor, the “**Parties**”).

Assignor hereby grants, transfers, sells, conveys, assigns and delivers to Assignee, free and clear of any liens, charges, pledges, security interests, imperfections of title, claims or other encumbrances, from and after the date hereof, all of Assignor’s right, title and interest of every kind and nature in and to the Registered Trademarks, together with the goodwill of the business connected with the use of, and symbolized by, the Registered Trademarks.
2. Assignee is hereby authorized to record this Assignment with the USPTO.
3. The Parties hereby agree to execute, acknowledge and deliver all instruments or documents, and take all action as may be necessary or useful to consummate the transactions contemplated hereby.
4. This Assignment may be executed in any number of counterparts, and each of which shall be deemed to be an original, but all of which shall be deemed to be one assignment. This Assignment may be executed by telefax or pdf signatures, which shall be binding and relied upon with the same force and effect as original signatures.
