**RELEASE OF SECURITY INTEREST  
IN CERTAIN TRADEMARK COLLATERAL**

This RELEASE OF SECURITY INTEREST IN CERTAIN TRADEMARK COLLATERAL, dated as of February 4, 2020 (this "Release"), is made by **THE BANK OF NEW YORK MELLON**, in its capacity as collateral agent pursuant to the Credit Agreement (as defined in the Collateral Agreement (as defined below)) (in such capacity, the "Collateral Agent"), in favor of **TRANS WESTERN POLYMERS, INC.** (the "Grantors"), as follows.

**WITNESSETH**

WHEREAS, the Grantors are party to a Collateral Agreement dated as of November 5, 2009 (as amended, restated, amended and restated, supplemented or otherwise modified prior to the date hereof, the "Collateral Agreement") in favor of the Collateral Agent pursuant to which the Grantors executed and delivered the trademark security agreement described below;

WHEREAS, pursuant to that certain Trademark Security Agreement, dated as of February 14, 2004 and recorded with the U.S. Patent and Trademark Office on February 14, 2014, at Reel/Frame No. 5216/0747 (as amended, restated, amended and restated, supplemented or otherwise modified prior to the date hereof, the "Trademark Security Agreement"), the Grantors granted to the Collateral Agent a continuing security interest in all right, title or interest in, to or under, the Trademarks of such Grantors described therein, including, without limitation, the United States trademark registrations and trademark registration applications set forth on Schedule A attached hereto (such registration and applications, the "Released Trademarks");

WHEREAS, the Grantors have requested that the Collateral Agent release its security interest in the Released Trademarks;

WHEREAS, the Collateral Agent has been authorized by the Applicable Representative to terminate and release its security interest in the Released Trademarks as provided in this Release;

NOW, THEREFORE, the Collateral Agent, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, without recourse, representation or warranty of any kind or nature, and at the Grantors' sole cost and expense, hereby terminates, cancels, discharges and releases its security interest in all right, title and interest in, to or under the Released Trademarks.


