RELEASE OF GRANT OF SECURITY INTEREST IN TRADEMARK RIGHTS

THIS RELEASE OF GRANT OF SECURITY INTEREST IN TRADEMARK RIGHTS dated as of January 31, 2020 (this "Release") is made by Bank of America, N.A., acting in its capacity as lender (in such capacity, the "Lender") under that certain Grant of Security Interest in Trademark Rights, dated as of June 26, 2018 (the "Trademark Security Agreement") by and between 20/20 Communications, Inc., a Delaware corporation (the "Grantor") and the Lender.

WHEREAS, pursuant to the Grant of Security Interest in Trademark Rights which was recorded in the records of the United States Patent and Trademark Office on June 29, 2018 at reel 006368, frame 0808, reel 006368, frame 0815 and reel 006368, frame 0835 the Grantor granted to the Lender a continuing security interest in all of Grantor's right, title and interest in, to and under its owned or thereafter acquired Collateral (as defined in the Trademark Security Agreement), including those trademark and service mark registrations and applications set forth on Schedule 1 attached hereto; and


WHEREAS, the Grantor has requested and Lender has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged:

1. Release. The Lender does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the Trademark Security Agreement in the Collateral, (b) release its security interest in the Collateral, and (c) discharge any and all rights, title and interest it has in the Collateral (including all associated goodwill) and the security interest granted to Lender in the Collateral.
2. Further Assurances. The Lender agrees to authenticate and deliver to the Grantor, at the expense of the Grantor, such other writings or records and make and do all such other and further acts or things, as the Grantor shall reasonably deem necessary or advisable to effectuate or better evidence the agreements and assignment contained in this Release.
3. Governing Law. This Release shall be governed by, and construed in accordance with, the laws of the State of New York.
