RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

THIS RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT dated as of February 4, 2020 (this "Release") is made by NEWSTAR FINANCIAL, INC., a Delaware corporation, in its capacity as Collateral Agent for the Secured Parties under that certain Intellectual Property Security Agreement, dated as of May 2, 2016 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "IP Security Agreement") by ERESEARCHTECHNOLOGY, INC., a Delaware corporation and PHT CORPORATION, a Delaware corporation (collectively, the "Grantors" and each individually, a "Grantor") in favor of the Collateral Agent. Capitalized terms used herein and not otherwise defined herein shall have the meaning ascribed to such terms in the IP Security Agreement.

WHEREAS, pursuant to the IP Security Agreement which was recorded (i) in the records of the United States Patent and Trademark Office on May 3, 2016 at reel 5783, frame 0463, (ii) in the records of the United States Copyright Office on May 16, 2016 at volume 9934, document 933, and (iii) in the records of the United States Patent and Trademark Office on June 6, 2016 at reel 038812, frame 0804, the Grantors granted to the Collateral Agent a continuing security interest in, and Lien on, all of Grantors' right, title and interest in, to and under its owned or thereafter acquired Patents, Trademarks and Copyrights, including those set forth on the attached Schedule I (the "Collateral"); and

WHEREAS, pursuant to that certain Payoff Letter, dated as of February 4, 2020, by and among the Grantors, the Collateral Agent, and the other parties party thereto, the Grantors have requested and the Administrative Agent has agreed to (a) release any and all security interests it may have in the Collateral and (b) provide a document suitable for recording in the United States Patent and Trademark Office and in the United States Copyright Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent does hereby (a) terminate the security interest and Liens created under the IP Security Agreement in the Collateral, (b) release its security interest in the Collateral, and (c) discharge any and all rights, title and interest it has in and the security interest granted to the Collateral Agent for the benefit of the Secured Parties in the Collateral. The Collateral Agent agrees, or authorizes the Grantors, to make filings with the United States Patent and Trademark Office and the United States Copyright Office and to take such further actions, as reasonably requested by the Grantors, to evidence the release and termination of the Collateral Agent's security interests in the Collateral.

THIS RELEASE SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK.
