RELEASE OF TRADEMARK SECURITY INTEREST

This **RELEASE OF TRADEMARK SECURITY INTEREST** is made as of February 11, 2020 by AB PRIVATE CREDIT INVESTORS LLC, as Administrative Agent for the Lenders ("Secured Party").

WITNESSETH:

WHEREAS, ESSEX TECHNOLOGY GROUP, LLC, a Delaware limited liability company (the "Grantor") and Secured Party are parties to that certain Pledge and Security Agreement, dated as of February 1, 2016 (the "Security Agreement");

WHEREAS, in connection with the Security Agreement, Secured Party and Grantor are parties to that certain Intellectual Property Security Agreement, dated as of February 1, 2016 (the "IP Security Agreement"), pursuant to which Grantor granted a security interest to Secured Party in the Intellectual Property (as defined in the IP Security Agreement) set forth in Schedule I attached hereto;

WHEREAS, Secured Party recorded the IP Security Agreement with the United States Patent and Trademark Office on February 2, 2016 at Reel/Frame 5720/0478; and

WHEREAS, Secured Party has agreed to release its rights under the IP Security Agreement and to re-convey to Grantor any and all rights in and to the Intellectual Property.

NOW, THEREFORE, in consideration of the premises and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged:

1. Secured Party hereby terminates, releases and discharges its security interest in all the Intellectual Property originally granted to Secured Party pursuant to the Security Agreement and the IP Security Agreement and releases all other rights it may have to the Intellectual Property under the Security Agreement and the IP Security Agreement.

2. Secured Party, to the extent granted in the Security Agreement or the IP Security Agreement, hereby assigns, grants and otherwise re-conveys to Grantor, without any representation, recourse or undertaking by Secured Party, all of its right, title and interest in and to the Intellectual Property originally granted to Secured Party pursuant to the Security Agreement or the IP Security Agreement.

3. Upon the request of Grantor, Secured Party, at Grantor's expense, further agrees to execute all documents necessary to demonstrate and confirm the parties' intent under this Release of Trademark Security Interest.
