NUNC PRO TUNC TRADEMARK ASSIGNMENT

This Nunc Pro Tunc Trademark Assignment (“Assignment”) is made of record between MLP Ventures Group, LLC (“Assignor”), a Pennsylvania limited liability company, and, MORNING LIGHT IP, LLC, a Delaware limited liability company with a business address of 201 King of Prussia Road, Suite 501 Radnor PENNSYLVANIA 19087 (“Assignee”).

RECITALS

1. Assignment. Assignor confirms that on or about December 16th, 2019, Assignor did and has assigned to Assignee: (1) all the property, right, title and interest in and to the Trademark including all common law rights connected therein together with the Application therefor for the United States and throughout the world together with the goodwill of the business in connection with which the Trademark is used and which is symbolized by the Trademark; (2) all income, royalties, and damages hereafter due or payable to Assignor with respect to the Trademark, including without limitation, damages, and payments for past or future infringements and misappropriations of the Trademark; and (3) all rights to sue for past, present and future infringements or misappropriations of the Trademark.
2. Acceptance. Assignee hereby acknowledges that it accepted the foregoing assignment for good and valuable consideration on or around December 16th, 2019 and wishes to evidence this assignment by executing this instrument.
