**PARTIAL RELEASE OF SECOND LIEN GRANT OF  
SECURITY INTEREST IN TRADEMARKS**

THIS PARTIAL RELEASE OF GRANT OF SECURITY INTEREST IN TRADEMARKS (“Partial Release”) is made effective as of February 27, 2020, by and from MORGAN STANLEY SENIOR FUNDING, INC., as collateral agent (in such capacity, the “Collateral Agent”) to ENTERPRISE ONLINE, LLC, a Delaware limited liability company (“Enterprise”). All terms not herein defined have the meanings set forth in the Security Agreement or the Second Lien Trademark Security Agreement referenced below.

WHEREAS, on February 8, 2019, Enterprise, the Collateral Agent and the other Grantors party thereto entered into that certain Supplement No. 1 (the “Supplement”) to the Second Lien Security Agreement, dated as of October 11, 2018, by the Grantors party thereto in favor of the Collateral Agent (together with the Supplement and all other amendments, supplements and modifications, if any, from time to time thereafter made thereto, the “Security Agreement”);

WHEREAS, on March 15, 2019, Enterprise and the other Grantors party thereto executed that certain Second Lien Grant of Security Interest in Trademarks (the “Second Lien Trademark Security Agreement”) granting to Collateral Agent (for its own benefit and the benefit of the other Lenders), a lien on and security interest in all of Enterprise’s right, title and interest in, to, and under certain Intellectual Property, including the Trademarks that are not Excluded Property listed on the schedules attached thereto;

WHEREAS, the Second Lien Trademark Security Agreement was recorded in the United States Patent and Trademark Office on March 21, 2019 at Reel 6597 Frame 0895; and


WHEREAS, Enterprise requests the Collateral Agent to release its interest in the Trademarks listed on Schedule A attached hereto only, and retransfer and reassign to Enterprise and their successors and assigns without recourse all of the Collateral Agent’s right, title and interest in and to the Trademarks listed on Schedule A attached hereto only.

NOW THEREFORE, the Collateral Agent hereby releases any security interest it may have in the Trademarks listed on Schedule A attached hereto only, including the goodwill associated therewith and all rights to receive Proceeds therefrom, and retransfers and reassigns any and all right, title and interest it may have in and to the foregoing without recourse to Enterprise.
