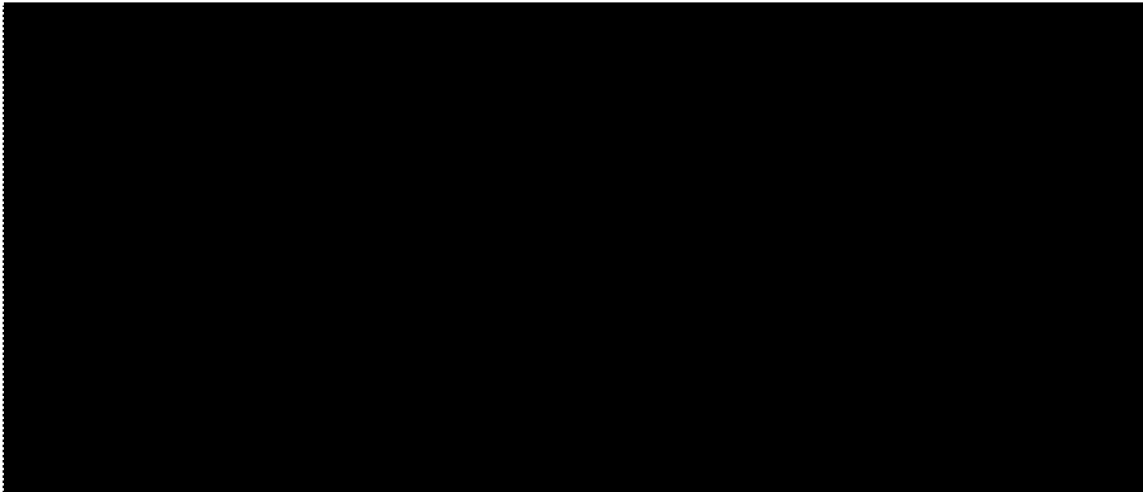
At Closing, Seller shall sell, convey, assign, and transfer to Purchaser, and


