RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE dated as of February 28, 2020 (this "Release") is made by NXT Capital, LLC, acting in its capacity as Agent (in such capacity, the "Agent") under that certain Trademark Security Agreement, dated as of November 25, 2015 (as amended, supplemented or modified and in effect from time to time, the "Trademark Security Agreement") by and among OrgSync, Inc., a Texas corporation (the "Grantor") and the Agent.

WHEREAS, pursuant to the Trademark Security Agreement which was recorded in the records of the United States Patent and Trademark Office on November 25, 2015 at reel 5676, frame 0351, the Grantor granted to the Agent a continuing security interest in all of Grantor's right, title and interest in, to and under its owned or thereafter acquired Trademark Collateral (as defined in the Trademark Security Agreement), including those set forth on the attached **Schedule A**;


WHEREAS, the Grantor has requested and the Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) discharge, cancel and terminate the liens and security interest in and to the Trademark Collateral, (b) release all of its security interest in the Trademark Collateral, and (c) re-assigns to Grantor any and all rights, title and interest it has in the Trademark Collateral, and (d) terminates the Trademark Security Agreement. The Agent agrees to take all further actions, and provide to the Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor, at the Grantor's sole cost and expense, to more fully and effectively effectuate the purposes of this Release.
