SBIC LP, a limited partnership formed under the laws of the State of Delaware, as agent for certain lenders (in such capacity, and together with its successors and assigns in such capacity "Assignor") that holds of record a security interest in the trademarks and service mark rights, statutory and common-law trademarks, trade names, corporate names, company names, business names, fictitious business names, trade styles, service marks, trade dress, logos owned by Healthcast, Inc., a Delaware corporation ("Healthcast") including the trademarks listed on Exhibit A (Trademarks) pursuant to (i) that certain Security and Pledge Agreement, dated as of August 25, 2014 by and among Healthcast and certain of its affiliates Assignor (as amended, amended and restated, supplemented and modified from time to time, "Security Agreement"), and (ii) that certain Notice of Grant of Security Interest in Intellectual Property between Assignor and Healthcast, recorded with the United States Patent and Trademark Office ("USPTO") at Reel 006372, Frame 0899 on July 5, 2018 (the "Notice of Security Agreement"), attached as Exhibit B, hereby absolutely and irrevocably assigns, sells, transfers and conveys to PNC Bank, National Association, as agent for certain lenders (in such capacity, and together with its successors and assigns in such capacity, "Assignee"), all of Assignor's right, title and interest in, to the Trademarks under the Security Agreement and to the Trademarks under the Notice of Security Agreement.

Assignor hereby authorizes and requests the Office of the Commissioner of Trademarks at the USPTO to record Assignee as the assignee of the security interest granted in and to the Trademarks under the Security Agreement.

This assignment shall, in accordance with Section 5-1401 of the General Obligations Law of the State of New York, be governed by and construed in accordance with the laws of the State of New York. This assignment may be executed in any number of and by different parties hereto on separate counterparts, all of which, when so executed, shall be deemed an original, but all such counterparts shall constitute one and the same agreement. Any signature delivered by a party by facsimile or other similar method of electronic transmission shall be deemed to be an original signature hereto.




