

Military Trail, Suite 420, Boca Raton, Florida 33431, **without any representation or warranty by, or recourse to**, Lender, arising under that certain Trademark Security Agreement dated January 24, 2017, as recorded in the United States Patent and Trademark Office on January 27, 2017, at Reel No. 5975, Frame 0657 (the "**Trademark Security Agreement**"), together with the goodwill of the business symbolized by the Trademark Collateral.

This Release of Security Interest in Trademarks (this "**Release**") is intended to operate as a release of all liens and security interests conveyed by Assignees to Lender pursuant to the terms of the Trademark Security Agreement, and to reassign to Assignees all of Lender's right, title, and interest acquired pursuant to the terms of such Trademark Security Agreement.
