**GRANT OF SECURITY INTEREST IN  
TRADEMARKS**

WHEREAS, each of the undersigned (collectively, the “Grantors” and each, a “Grantor”) has adopted, used and is using, and holds all right, title and interest in and to, the trademarks and service marks listed on the annexed Schedule 1, which trademarks and service marks are registered or applied for in the United States Patent and Trademark Office and the Canadian Intellectual Property Office (the “Trademarks”);

WHEREAS, each Grantor has entered into a Loan and Security Agreement, dated March 13, 2020 (as amended, restated, supplemented or otherwise modified from time to time, the “Loan Agreement”), in favor of Encina Business Credit, LLC, in its capacity as agent for certain lenders (the “Grantee”);

WHEREAS, pursuant to the Loan Agreement, each Grantor has granted to the Grantee for the benefit of the lenders a continuing security interest in all right, title and interest of such Grantor in, to and under the Trademarks, together with, among other things, the good-will of the business symbolized by the Trademarks and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof (the “Collateral”), to secure the payment, performance and observance of the Obligations (as defined in the Loan Agreement);

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each Grantor does hereby pledge unto the Grantee and grants to the Grantee for the benefit of the lenders a continuing security interest in the Collateral (excluding all Excluded Property) to secure the prompt payment, performance and observance of the Obligations.

Each Grantor does hereby further acknowledge and affirm that the rights and remedies of the Grantee with respect to the Collateral are more fully set forth in the Loan Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.


