**PARTIES**

- (1) Remka Inc., with its principal place of business at 12266 Queenston Boulevard, Suite A, Houston, Texas 77095 (“REMKA”); and
- (2) PocketWatch, Inc., with its principal place of business at 8500 Steller Dr., Building 7, Culver City, California 90232 (“PocketWatch”). Remka and PocketWatch are individually referred to each as a “Party” or collectively as the “Parties”.

**BACKGROUND**

- (A) Remka (and its related entities) is the owner of the “RYAN TOYSREVIEW” and “RYAN’S WORLD” properties (collectively referred to as “RYAN’S WORLD”) in the United States and throughout the world. “RYAN’S WORLD” is one of the most prominent YouTube channels in the world and “RYAN’S WORLD” and related marks and brands are directly derived from this property. Remka and PocketWatch have a contractual licensing relationship for the expansion of the “RYAN’S WORLD” property into various categories.
- (B) As part of the development and expansion of Remka’s properties, PocketWatch has created the following logo for Remka as follows:



The above “RYAN AND FRIENDS” logo is herein referred to as the “Logo Mark”. The Logo is solely and exclusively owned by Remka as confirmed under the terms of the licensing agreement between Remka and PocketWatch.

- (C) Further, on or around November 26, 2019, PocketWatch filed an application with the United States Patent and Trademark Office (“USPTO”) for the standard character word mark “RYAN AND FRIENDS”, Application Serial No. 88708185 in Class 41 for the following services: *Distribution of motion picture films; Distribution of radio programs*

*for others; Distribution of television programs for others; Fan clubs; Virtual reality game services provided on-line from a computer network; Production and distribution of motion pictures; Production and distribution of radio programs; Production and distribution of television shows and movies; Production and distribution of videos in the field of children's entertainment; Provision of information relating to distribution of television shows, motion picture film and radio shows.* The above word mark is hereinafter referred to as the "Word Mark". Currently, the Word Mark is being published for opposition by the USPTO. The Word Mark is solely and exclusively owned by Remka as confirmed under the terms of the licensing agreement between Remka and PocketWatch.

(D) The Parties wish to confirm the transfer of the Logo Mark and Word Mark to Remka, and the Parties have entered into this confirmatory assignment to confirm the ownership of all Intellectual Property Rights (as defined below) in and to the Logo Mark and Word Mark reside with Remka.

### **AGREED TERMS**

#### **ASSIGNMENT**

In consideration of the sum of USD \$10.00 (receipt and sufficiency of which PocketWatch hereby acknowledges) and the mutual obligations and responsibilities between the Parties, PocketWatch hereby confirms the assignment to Remka all right, title and interest in and to the Logo Mark and Word Mark, including without limitation the Intellectual Property Rights in the Logo Mark and Word Mark (as shown in Schedule 1). For the purpose of this Agreement, "Intellectual Property Rights" mean all copyrights and related rights, trademarks and service marks, business names and domain names, rights in get-up and trade dress, goodwill and the right to sue for passing off or unfair competition, rights in designs, and all other intellectual property rights, in each case whether registered or unregistered, throughout the universe.
