WHEREAS, it is desired that the assignment of the Trademarks be made a matter of record in the appropriate patent offices;


NOW THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Assignor hereby confirms the assignment, transfer and delivery to Assignee of all Assignor's right, title, And interest in and to the Trademarks, together with all common law rights thereto, all right to claim priority in accordance with International treaties and conventions, the goodwill associated therewith and symbolized thereby, and the right to sue and recover damages for past, present and future infringements, dilutions or misappropriations of such Trademarks.

Assignor hereby grants full power of attorney to Assignee to submit this Deed of assignment, including the Annex, to the trademark authorities of the United States of America, and to request those authorities to record the assignment of the legal title to the Assigned Trademarks from Assignor to Assignee in the appropriate registers.


