WHEREAS, Assignee, a limited liability company organized under the laws of the State of Florida, located and doing business at 3001 SW 3<sup>rd</sup> Avenue, Miami, Florida 33129 recorded the assignment on August 30, 2018.

WHEREAS, Assignor and Assignee (collectively referred to herein as the "Parties") are still active limited companies in the State of Florida.

WHEREAS, it came to Assignee's attention that a typographical error was contained in the original Assignment, namely, that the attached "Schedule" misspelled the Mark as COLOUREPUBLIC.

WHEREAS, the Parties are desirous of confirming the prior Assignment and correcting the error contained in the same.

WHEREAS, prior to the August 26, 2018 Assignment, Assignor had adopted, used and was using the Mark in U.S. commerce.

WHEREAS, it was Assignor's intent to assign the Mark, including the goodwill associated therewith to Assignee and it was Assignee's intent to acquire the Mark, the registration therefor and the goodwill associated therewith.

WHEREAS, subsequent to August 26, 2018, Assignee has used and is continuing to use the Mark in U.S. commerce.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby confirms and corrects the prior Assignment and confirms that on August 26, 2018, it assigned, transferred, conveyed, set over, and delivered unto Assignee and Assignee's successors and assigns forever: (i) all of Assignor's right, title, and interest in and to the Mark, together with the goodwill of the business connected with the use thereof and symbolized thereby; (ii) the right to apply for and obtain registrations for the Mark and all rights of renewal and extensions thereof; (iii) all common-law rights related to the Mark; and (iv) the right to sue for all past, present, and future infringements, dilutions, and other violations of the Mark and to recover damages and other amounts related thereto. Assignor will cooperate and work with Assignee and will provide and execute any and all additional papers, documents, or instruments necessary to complete the confirmatory and corrective Assignment herein and vest title to and ownership of the Mark in Assignee.



## Guidelines for Completing Trademarks Cover Sheets (PTO-1594)

Cover Sheet information must be submitted with each document to be recorded. If the document to be recorded concerns both patents and trademarks, separate patent and trademark cover sheets, including any attached pages for continuing information, must accompany the document. All pages of the cover sheet should be numbered consecutively for example, if both a patent and trademark cover sheet is used, and information is continued on one additional page for both patents and trademarks, the pages of the cover sheet would be numbered from 1 to 4.

### Item 1. Name of Conveying Party(ies).

Enter the full name of the party(ies) conveying the interest. If there is more than one conveying party, enter a check mark in the "Yes" box to indicate that additional information is attached. The name of the second and any subsequent conveying party(ies) should be placed on an attached page clearly identified as a continuation of the information in Item 1. ### Item 4. Application Number(s) or Registration Number(s).

Indicate the application number(s) including series code and serial number, and/or registration number(s) against which the document is to be recorded. ### Item 9. Signature.
