RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Release") is made as of March 12, 2020 ("Effective Date") by THE GOVERNOR AND COMPANY OF THE BANK OF IRELAND, as Collateral Agent for the Secured Parties (the "Collateral Agent"), in favor of ENHANCED VISION SYSTEMS, INC. (the "Grantor"). Capitalized terms not defined herein shall have the meanings ascribed to such terms in the Intellectual Property Security Agreement (as defined below).

WHEREAS, the Grantor and the Collateral Agent entered into that certain Second Lien U.S. Pledge and Security Agreement by and among the Grantor, the other grantors party thereto and the Collateral Agent, dated as of November 10, 2015 (as amended, restated, supplemented or otherwise modified from time to time, the "Pledge and Security Agreement") wherein Grantor granted to the Collateral Agent a lien on and security interest in all of its right, title and interest in and to the Collateral (as defined therein) of Grantor;

WHEREAS, pursuant to the Pledge and Security Agreement, that certain Second Lien Intellectual Property Security Agreement (the "Intellectual Property Security Agreement"), dated April 9, 2018, was entered into by the Grantor and the Collateral Agent to record the security interest with respect to the Intellectual Property Collateral (as defined in the Intellectual Property Security Agreement) of Grantor, including, without limitation, those items set forth on Schedule A hereto;

WHEREAS, the Intellectual Property Security Agreement was recorded with the United States Patent and Trademark Office on April 10, 2018, at Reel/Frame 045914/0125 with respect to patents, and at Reel/Frame 6313/0321 with respect to trademarks; and

WHEREAS, the Grantor requests a specific release of the security interests and liens granted against the Intellectual Property Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby, on behalf of itself and the Secured Parties, (i) releases and re-assigns to Grantor any and all liens, security interests, right, title and interest it may have in, to and under the Intellectual Property Collateral, together with the goodwill of the business symbolized thereby; (ii) agrees that it shall execute all other documents and do all other acts reasonably necessary and requested by Grantor in writing to relinquish and effect the release of such rights to Grantor; and (iii) authorizes and requests that the United States Patent and Trademark Office or the United States Copyright Office, as applicable, note and record the release hereby given and any other filings necessary to evidence the release and termination of the Collateral Agent's rights under the Pledge and Security Agreement with respect to the Intellectual Property Collateral.


