(Conversion to Professional Limited Liability Company)

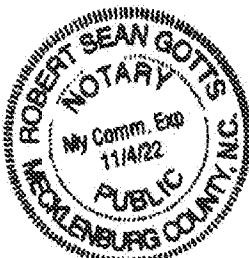
