IN UNITED STATES TRADEMARKS**


FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, YRC Worldwide Inc., a Delaware corporation, with principal offices at 10990 Roe Avenue, Overland Park, Kansas 66211 (the "Grantor") hereby grants to Citizens Business Capital, a division of Citizens Asset Finance, Inc., a subsidiary of Citizens Bank, N.A., as Agent, with principal offices at PW-2615, 525 William Penn Place, Pittsburg, PA 15219, Attention: David Slattery, Vice President (the "Grantee"), a continuing security interest in (i) all of such Grantor's right, title and interest in, to and under the United States trademarks, trademark registrations and trademark applications (collectively, the "Marks") set forth on Schedule A attached hereto, (ii) all Proceeds (as such term is defined in the Loan and Security Agreement referred to below) and products of the Marks, (iii) the goodwill of the businesses with which the Marks are associated and (iv) all causes of action arising on, prior to or after the date hereof for infringement, or dilution of, or other injury to, any of the Marks or unfair competition regarding the same.

The rights and remedies of the Grantee with respect to the security interest granted herein are as set forth in the Loan and Security Agreement, all terms and provisions of which are incorporated herein by reference.
