STIPULATION ORDER RESOLVING RECEIVERSHIP ACTION

This matter is before the Court on the Parties' Stipulation (A) Resolving WalkMed, LLC's Motion for Relief from Receivership Order, and (B) for Discharge of Receiver (Doc. # 36). Having reviewed the Stipulation and pertinent record, the Court hereby ORDERS:

1. The Stipulation (Doc. # 36) is APPROVED in its entirety, including the Parties' agreed upon definitions for the following terms: "Trademark," "WalkMed Assets," and "Receivership Action." Those definitions are incorporated herein.
2. Cordes & Company, solely in its capacity as receiver for WalkMed Infusion, LLC, is discharged.


3. WalkMed, LLC is declared the owner of the WalkMed Assets, including the "WalkMed" Trademark, United States Patent and Trademark Office registration number 2230655, and has been in continuous use of such trademark since acquiring the WalkMed Assets on or about June 27, 2017.

4. The Receivership Action is TERMINATED.

5. The Clerk of the Court is respectfully DIRECTED to TERMINATE this action.
