TRADEMARK ASSIGNMENT AGREEMENT

Assignor does hereby assign, transfer and convey unto Assignee, and its successors, assigns and legal representatives, all right, title and interest in and to the Trademark together with all common law rights and all that part of the goodwill of the business connected with the use of and symbolized thereby, and all claims for damages by reason of past infringement with the right to sue for and collect damages.



IN WITNESS WHEREOF, each party has executed this Agreement by its duly authorized representative on the date set forth above.


