## TRADEMARK ASSIGNMENT

Assignor irrevocably authorizes the officials at the USPTO to record the transfer of the Trademark to Assignee as assignee of Assignor's entire right, title and interest therein.

This Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which taken together shall constitute one and the same instrument.

This Assignment shall be governed and construed in accordance with the laws of the State of Florida.


