**INTELLECTUAL PROPERTY**  
**ASSIGNMENT AGREEMENT**

THIS INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT (the “Assignment”) is made and entered into to be effective as of December 21, 2018 (the “Effective Date”) from **TruPet, LLC**, an Ohio limited liability company (the “Assignor”), to **TruPet, LLC**, a Delaware limited liability company (the “Assignee”).

WHEREAS, Assignor is the owner of record for the trademarks registered with the United States Patent and Trademark Office and listed on Exhibit A, attached hereto and incorporated herein by reference (the “Trademarks”);

WHEREAS, Assignor has converted from an Ohio limited liability company to a Delaware limited liability company pursuant to a Certificate of Conversion effective as of the Effective Date;

WHEREAS, Assignee is the successor entity to Assignor, and by operation of state law, Assignee possesses all assets and property of every description of Assignor and every interest in the assets and property of Assignor, wherever located, along with all rights privileges, immunities, powers, franchises and authority of Assignor, pursuant to Ohio Rev. Code § 1705.391 and Del. Code tit. 6 § 18-214; and

WHEREAS, Assignor is executing this Assignment to evidence the transfer to Assignee of all right, title and interest of Assignor in and to the Trademarks.

NOW, THEREFORE in consideration of the mutual covenants, terms and conditions set forth herein, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby agrees as follows:

1. Assignment. As of the Effective Date, Assignor does hereby irrevocably transfer, assign, convey and deliver unto the Assignee, its successors and assigns, all of Assignor’s entire world-wide right, title and interest in and to the Trademarks, together with the goodwill of the business in connection with which the Trademarks are used or will be used, free and clear of all liens, claims, and encumbrances, including without limitation:

a. any and all inventions, ideas, methods, processes, concepts, designs, technology, know-how and proprietary information, whether patentable or subject to trade secret protection, or not, and the right to pursue any patent applications thereon, relating to the Trademarks;

b. any and all copyrights of the Assignor, any registrations and applications relating thereto, and any renewals and extensions thereof, including without limitation works of authorship, masterworks, schematics, computer software, and software code, relating to the Trademarks;

c. any and all documents and documentation (whether in written or electronic form) related to, containing or used in the development of the Trademarks;

d. any and all causes of action, either in law or in equity, including the rights to sue, counter claim, cross-claim and recover, for past, present, or future infringement or misappropriation of any of the Trademarks; and

e. any and all income, royalties, damages, claims and payments now or hereafter due or payable with respect to the Trademarks.

2. Representations and Warranties. Assignor hereby represents and warrants as follows: (a) to the best of Assignor's knowledge, the Trademarks do not conflict with or infringe on any patents, trademark registrations, trade names or copyrights of any third parties; and (b) Assignor has not received any notices of an infringement by any third party with respect to the Trademarks.

3. Warrant and Defend. Assignor, for Assignor's self and Assignor's successors and assigns, covenants and agrees to and with Assignee and Assignee's successors and assigns to warrant and defend the title to the Trademarks pursuant to this Assignment against any and every individual and entity whomsoever.

4. Further Acts. Assignor agrees, at any time, and from time to time after the Effective Date, upon request of Assignee, to execute, acknowledge and deliver, or will cause to be executed, acknowledged and delivered, all such further acts, deeds, assignments, transfers, conveyances, powers of attorney or assurances as Assignee may deem necessary for the better assigning, transferring, conveying and confirming to Assignee any of the Trademarks herein assigned. Assignor does hereby irrevocably constitute and appoint Assignee as Assignor's true and lawful attorney-in-fact, with full power of substitution, to transfer the Trademarks.

5. Miscellaneous.

a. Headings. The headings in this Assignment are for convenience of reference only and shall not limit or otherwise affect any of the terms or provisions hereof.

b. Governing Law. This Assignment and the rights and obligations of the parties hereto shall be governed by and construed and enforced in accordance with the laws of the State of Delaware. Any action, suit or proceeding relating to or arising out of this Assignment shall be brought in, and the parties hereby consent to service of process, personal jurisdiction and venue in, the state and federal courts of general jurisdiction located in Delaware.

c. Binding Effect. This Assignment will inure to the benefit of and be binding upon the parties hereto and their respective successors, assigns, estates, heirs and legal representatives.

d. Recitals. The recitals contained herein are made a part of this Assignment.

e. Counterparts. This Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed to be one and the same agreement. A signed copy of this Assignment delivered by facsimile, email or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Assignment.
