NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, Assignor does hereby irrevocably assign, sell, and transfer unto Assignee, all ownership, right, title and interest in and to the Marks, including the right to sue for damages and other remedies in respect of any infringement of the Marks which may have occurred before or on the date of this Agreement, together with the goodwill of the business symbolized by the Marks.

Assignee shall file this Agreement with the Assignments Division (Trademarks) of the United States Patent and Trademark Office.


Each party hereto agrees, upon the reasonable request of the other party hereto to make, execute and deliver any and all documents or instruments of any kind or character, and to perform all such other actions, that may be reasonably necessary or proper to effectuate, confirm, perform or carry out the terms or provisions of this Agreement.




