TRADEMARK ASSIGNMENT CONFIRMATION

WHEREAS the Parties desire to execute this Confirmation to confirm the ownership of the trademarks by ODT and allow recordation of the transfer of rights from DLT to ODT;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties confirm and agree as follows:

1. DLT hereby confirms that it sold, assigned, transferred, and set over to ODT, and to the extent that it did not, hereby sells, assigns, transfers, and sets over to ODT, all rights, title, and interest in and to the trademarks listed on Schedule A, together with any and all registrations for such trademarks and the goodwill of the business symbolized by the trademarks.
2. ODT hereby accepts assignment of the trademarks and registrations.
