## ASSIGNMENT OF TRADEMARK RIGHTS

This Assignment of Trademark Rights (this "Agreement") is made and entered into effective as of July 31, 2019, by and between Hudson Home Group LLC ("Hudson" or "Assignee"), having an address at 85 Fulton St., Boonton, NJ 07005 and MSA Products, Inc. WHEREAS Assignor owns US Trademark Registration Nos. 4517977 (COOKS CLUB QUALITY & DESIGN) and 4721199 (COOKS' CLUB) (both of MSA's marks, collectively the "MSA Marks") (both of MSA's Registration Nos. 4517977 and 4721199 referred to collectively as the "MSA Registrations" or "Assigned Marks");

WHEREAS, Assignor has agreed to transfer to Assignee the Assigned Marks, including the common law rights, registrations, applications and any goodwill associated therewith.

NOW, THEREFORE, in consideration of the mutual promises of the Parties hereto, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties agree as follows:

1. Assignment. Assignor does hereby assign unto Assignee all of its right, title and interest in and to the Assigned Marks, together with all of its associated goodwill and common law rights appurtenant thereto, and all rights of action and remedies for past, present and future infringements of any of the Assigned Marks.
2. Recordation and Further Actions. Assignor authorizes the Commissioner for Trademarks and any other governmental officials to record and register this Agreement upon request by Assignee. Assignor shall execute and deliver any and all instruments and documents and take such further actions as may be reasonably necessary to effect this assignment.
3. Successors and Assigns. This Agreement and all of the provisions hereof shall be binding upon and inure to the benefit of the Parties hereto and their respective successors and assigns.
4. Governing Law. This Agreement shall be governed by the laws of the State of New York.
5. Counterparts. This Agreement may be executed in two (2) or more counterparts, including by electronic transmission in PDF format, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.


