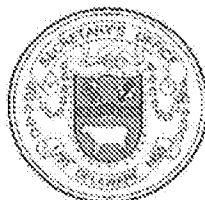

SIXTH: The Merger is to become effective upon the filing of this Certificate of Merger with the Secretary of State of the State of Delaware.



Under Section 1003 of the New York Limited Liability Company Law.

Pursuant to Section 1003 of the New York Limited Liability Company Law (the "NYLLCL"), each of the undersigned hereby certifies on behalf of the constituent entities named herein, as follows:

FIRST: The name of each of the constituent entities are Blackman Plumbing Supply Company, Inc., a New York corporation ("Old BPS"), and Blackman Plumbing Supply Co., LLC, a Delaware limited liability Company ("New BPS").

SECOND: Old BPS filed its certificate of incorporation with the Secretary of State of the State of New York (the "Secretary of State") on June 11, 1934.

THIRD: An agreement and plan of merger (the "Agreement and Plan of Merger") has been approved and executed by each constituent entity.

FOURTH: The name of the surviving entity of the merger is Blackman Plumbing Supply Co., LLC, a Delaware limited liability company (the "Surviving Entity").

FIFTH: New BPS filed its certificate of formation with the Secretary of State of the State of Delaware on September 8, 2017. New BPS filed its application for authority to do business in New York with the New York Department of State on September 27, 2017 (under the fictitious name "BPS Merger Sub LLC").

SIXTH: The Surviving Entity agrees that it may be served with process in the State of New York in any action or special proceeding for enforcement of any liability or obligation of Old BPS and agrees to the enforcement, as provided in the NYLLCL, of the right of shareholders of Old BPS to receive payment for their interests against the Surviving Entity.

SEVENTH: Pursuant to Section 623 of the New York Business Corporation Law and Section 1005 of the NYLLCL, or any applicable statute, the Surviving Entity will promptly pay to the shareholders of Old BPS the amount, if any, to which they shall

be entitled under the provisions of the NYLLCL and any applicable statute relating to the right of shareholders to receive payment for their interest.

EIGHTH: The Surviving Entity appoints the Secretary of State of New York as its agent to accept services of process in the manner set forth in Article 3 of the NYLLCL. The address within the State of New York to which the Secretary of State shall mail a copy of any process against the Surviving Entity served upon him or her is:

NINTH: The merger is permitted by the State of Delaware and is in compliance therewith.

TENTH: The Agreement and Plan of Merger is on file at the place of business of the Surviving Entity located at 900 Sylvan Avenue, Bayport, NY 11705.

ELEVENTH: A copy of the Agreement and Plan of Merger will be furnished by the Surviving Entity on request and without cost, to any member or equity holder of the constituent entities.
