LICENSE AGREEMENT CONFIRMATION

This License Agreement Confirmation is executed by and between Nicholas Barraco ("Licensor"), an individual with a principal address of 25726 Olympic Drive, Monee, IL 60449, and Dutch Farms, Inc. NOW, THEREFORE, to whom it may concern, be it known that for the consideration described in the Trademark License Agreement, Licensor and Licensee hereby confirm that Licensor exclusively licensed the Trademark to Licensee as of February 24, 2020, subject to all of the terms and conditions set forth in the Trademark License Agreement.


