TRADEMARK ASSIGNMENT

Assignor represents and warrants (i) that Assignor is the exclusive owner of trademark registration 5,593,833, (ii) that Assignor possesses all rights, title and interest in and to trademark registration 5,593,833, (iii) that Assignor has the power to enter into this Assignment, and (iv) that the rights transferred in this Assignment are free of any lien, encumbrance or adverse claim.


Assignor authorizes the Commissioner of Trademarks of the United States and other empowered officials of the United States Patent and Trademark Office and in any applicable jurisdictions outside the United States to record the transfer of trademark registration 5,593,833 to Assignee as assignee of Assignor’s entire right, title and interest therein. Assignor agrees to

further execute any documents or take any reasonable action necessary to effect, secure, and complete this assignment or to confirm Assignee's ownership of trademark registration 5,593,833.


