TRADEMARK ASSIGNMENT

NOW, THEREFORE, in consideration of the sum of Ten and No/100 Dollars (\$10.00) to said ASSIGNOR in hand paid, and other good and valuable consideration, the receipt of which is hereby acknowledged, said ASSIGNOR does hereby sell, assign, transfer and set over, unto said ASSIGNEE, its successors, legal representatives and assigns, the entire right, title and interest in, to and under said Trademarks, and all renewals or reissues of the registration thereof and all applications for trademarks which may hereafter be filed for said Trademarks in any country or countries foreign to the United States, together with the right to file such applications and the right to claim for the same the priority rights derived from said United States registration under the Trademark Laws of the United States or any international agreement or the domestic laws of the country in which any such application is filed, as may be applicable; together with the goodwill of the business symbolized by the Trademarks and said applications to register said Trademarks; and any and all causes of action thereto that may have heretofore accrued in ASSIGNOR’S favor.

AND ASSIGNOR HEREBY authorizes and requests the Commissioner of Patents and Trademarks of the United States, any Official of any State of the United States, and any Official of any state, country or countries foreign to the United States, whose duty it is to issue trademark or other evidence or forms of trademark protection, to issue the same to said ASSIGNEE, its successors, legal representatives, and assigns, in accordance with the terms of this instrument.

AND ASSIGNOR HEREBY covenants that all information in the Applications/Registrations is true and correct to the best of ASSIGNOR’S knowledge, and that ASSIGNOR has full right to convey the entire interest herein assigned, and that ASSIGNOR has not executed, and will not execute, any agreement in conflict herewith.

AND ASSIGNOR HEREBY further covenants and agrees that ASSIGNOR will communicate to said ASSIGNEE, its successors, legal representatives and assigns, any facts known to ASSIGNOR respecting said marks, and testify in any legal proceeding, sign all lawful papers, make all rightful oaths and generally do everything possible to aid said ASSIGNEE, its

successors, legal representatives and assigns, to obtain and enforce proper trademark protection for said mark in all countries.
