## **TRADEMARK ASSIGNMENT AGREEMENT**


NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

Assignor hereby assigns to Assignee Assignor’s entire right, title, and interest in and to the Mark and respective registration, together with any and all of the goodwill of the business symbolized by and associated with the Mark, and all income, royalties, fees, damages, and payments now or hereafter due or payable with respect thereto, and all rights of actions, powers, and benefit to the Mark, due or accrued, and including the right to sue for and recover in the Assignee’s own name and that of its successors and assigns and other legal representatives all remedies of every nature, including without limitation rights to injunctive relief, damages, profits, royalties, costs, and attorney fees, arising out of any infringement of the Mark, or injury to the related goodwill, occurring prior to or after the date of this Assignment.


