These Notice of Merger are entered into pursuant to Section 347.129 of the Missouri Limited Liability Company Act (the "Act") this 13th day of November, 2014, by and between BRP Hold 32, LLC, a Delaware limited liability company ("BRP") and Dead Down Wind, LLC, a Missouri limited liability company ("DDW", and together with BRP, the "Constituent Companies"), pursuant to which DDW shall be merged with and into BRP (the "Merger").

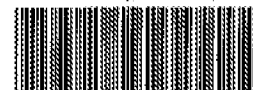
1. The name, state of organization and type of each of the Constituent Companies are:
