Service mark Assignment Agreement

This Service mark Assignment Agreement (hereafter "Agreement") is made this 4th day of June 2020 (the "Effective Date"), between:

Original Hot Dog Shops, Inc., a Pennsylvania corporation having a business address at 3901 Forbes Avenue, Pittsburgh, Pennsylvania 15213, as the Federal service mark registration owner (hereafter "Assignor"), and

both (i) Bruce Simon, an individual having an address at 31 Thornycroft Road, Pittsburgh, Pennsylvania 15235, and (ii) his sister, Terry Campasano, an individual having an address at 2347 Saddle Drive, Allison Park, Pennsylvania 15101, both Bruce Simon and Terry Campasano being the future service mark co-owners as joint tenants with a right of survivorship (hereafter "Assignees").

The Assignor is the owner of the word-only service mark, ORIGINAL HOT DOG SHOP, for which an application Federal Registration was filed on July 26, 1996, and assigned U.S. Serial No. 75150718 by the United States Patent and Trademark Office; which application was registered in IC class no. 042, on October 28, 1997 as Federal Registration No. 2108699 and which was most recently renewed on December 6, 2016.

The Assignees wishes to acquire all of Assignor's rights in the aforesaid registered service mark, any and all common law rights therein PLUS any and all Goodwill associated with the same.

The Assignees agrees to pay Assignor one U.S. dollar (\$1.00) plus other good and valuable consideration past receipt of which is hereby expressly acknowledged.

In exchange for the foregoing, Assignor hereby conveys, transfers, and assigns to the Assignees, as joint tenants with a right of survivorship, all of Assignor's right, title, and interest of whatever kind in the mark, together with:

1) the goodwill of the business relating to the products and services on which the marks are used and for which they are registered,

2) all income, royalties, and damages hereafter due or payable to Assignor with respect to the marks, including without limitation, damages, and payments for past or future infringements and misappropriations of the marks, and

3) all rights to sue for past, present and future infringement or misappropriations of the marks.

Assignor further covenants that it will take all actions that may be necessary for securing, completing, or vesting in the Assignees full right, title, and interest in the mark and its related property.
