Pursuant to the Section 14-2-1109 of the Georgia Business Corporation Code ("Code"), the undersigned entity adopts the following articles of merger:

1. Name and State of Incorporation or Organization of Constituent Entities. The names and states of formation or organization of the constituent entities to the proposed merger are (a) MemberClicks, Inc., a Georgia corporation (the "Merging Company"), and (b) MemberClicks, LLC, a Delaware limited liability company (the "Surviving Company").

2. Agreement of Merger. An Agreement and Plan of Merger ("Merger Agreement"), dated as of February 6, 2017, by and among the Surviving Company, the Merging Company, Richard Marsden, and the shareholders of the Company has been duly authorized and approved by the Surviving Company and the shareholders of the Merging Company in accordance with Code Section 14-2-1103.

3. Surviving Entity. The Surviving Company shall be the merger's surviving entity, and its name, "MemberClicks, LLC", shall not change as a result of the merger.

4. Location of Merger Agreement. The executed Merger Agreement is on file at the place of business of the Surviving Company, located at 3495 Piedmont Road NE, Building 12, Suite 110, Atlanta, GA 30305.

5. Furnishing of Agreement of Merger. A copy of the Merger Agreement will be furnished by the Surviving Company, on request and without cost, to any member of the Surviving Company or any shareholder of the Merging Company.


6. Effective Date. Pursuant to the terms of the Merger Agreement, the merger shall become effective as of the date and time of the filing of the Certificate of Merger with the Secretary of State of the State of Delaware.

7. Publication of Notice. Pursuant to Section 14-2-1105.1(a) of the Code, the Surviving Company does hereby undertake to submit the request for publication of a notice of filing of these Articles of Merger and payment therefor as required by Section 14-2-1105.1(b) of the Code.
