TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (this "Trademark Assignment") is made and entered into as of May 21, 2020, by and among Fastly, Inc., a Delaware Corporation ("Assignee"), Tesuto, Inc., a Delaware Corporation ("Assignor 1"), Tesuto LLC, a California limited liability company ("Assignor 2" and, together with Assignor 1, "Assignors"). WHEREAS, upon the terms and subject to the conditions of the Asset Purchase Agreement, the Assignors have agreed to sell, transfer, convey and deliver to the Assignee, and the Assignee has agreed to purchase, acquire and accept from the Assignors, all of the Assignors' right, title and interest in and to the Transferred Assets.

WHEREAS, it is the intention of the parties hereto to record the transfer of certain Trademarks included in the Transferred Assets by the execution and delivery of this Trademark Assignment at the Closing Date.

NOW, THEREFORE, in consideration of the covenants, promises and representations set forth herein and in the Contribution Agreement and for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

1. For good and valuable consideration, the receipt of which is hereby acknowledged, Assignors hereby irrevocably assigns to Assignee, its entire right, title and interest in and to the Trademarks and the applications, registrations and/or common law rights related thereto, identified on Schedule A, including the goodwill of the business connected with the use of, and symbolized by, said Trademarks, and the right to recover for past, present and future infringement of said Trademarks. Assignee hereby accepts said assignment.
2. Assignors do hereby authorize and request the Commissioner of Patents and Trademarks of the United States of America or equivalent authority elsewhere in the world to record this assignment and to issue such Trademark as shall be granted upon said applications based thereon to Assignee, its successors and assigns.
