## TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT ("Assignment"), is effective as of June 26, 2020, between KINAE Brands, LLC, an Ohio limited liability company, located at 7280 North Timberlane Drive, Madeira, Ohio 45243 ("Assignor"), and H & H, LLC, an Ohio limited liability company, located at 1194 Wintercrest Circle, Milford, Ohio 45150 ("Assignee"). 1. **Trademarks.** Assignor hereby irrevocably assigns, conveys, grants and transfers to Assignee all of Assignor's right, title and interest to the Mark, the goodwill associated with and symbolized by the Mark as well as any other rights at common law or otherwise.
2. **Rights.** The foregoing assignment includes rights to collect royalties or proceeds in connection with any of the foregoing and all rights to sue for and otherwise object to past, present or future infringement, misappropriation or other violation of the foregoing, and all rights to recover damages or lost profits in connection therewith.
3. **Further Assurances.** Assignor will promptly take such actions, including, without limitation, the prompt execution and delivery of documents in recordable form, as may be reasonably requested by Assignee to vest, secure, and perfect, the rights and interests of Assignee in and to the Trademark assigned herein.
4. **Binding Effect.** This Assignment inures to the benefit of and is binding upon Assignor and Assignee and their respective heirs, successors and permitted assigns.
