## Trademark transfer agreement

This Trademark Transfer Agreement ("Transfer Agreement") is entered into by and between the following parties on June 22, 2020

Assignor: Jinhua Niupin E-Commerce Co., Ltd., a Limited Company of China with the address of Rm. 209, No. 26, Yishan Rd. Wangxiatan, Wucheng Dist. Jinhua, Zhejiang CHINA;

Whereas, the Parties agree that Assignor transfers all the rights, obligations and liabilities (if any) under the Contract to Assignee.

1. Assignor does hereby assign to Assignee all right, title and interest in and to U.S. Registration number: 5285481 together with the goodwill of the business symbolized by the trademark.
2. Assignor warrants that the right is free from defects of any kind, including the use of or unauthorized use by others or as collateral
3. Assignor warrants that after the entry into force of this Agreement, it will not seek in any way any interest in the Trademarks, including title, usufruct, proceeds, disposition, and all such rights will be owned by Assignee

4. If the application for trademark is rejected by the Trademark Office, the Assignor shall return the full trademark transfer fee

5. Assignor shall ensure that the Transferred Trademark is a valid Trademark and that no third party owns the Trademarks

6. After the transfer of the trademark right, Assignee's authority:
