ASSIGNMENT AND QUITCLAIM

Assignor authorizes the Commissioner of Trademarks of the United States and other empowered officials of the USPTO to record the transfer of the applications for the Mark to Assignee as assignee of Assignor's entire right, title and interest therein. Assignor agrees to further execute any documents reasonably necessary to effect this assignment or to confirm Assignee's ownership of the Mark.
