TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement (“Agreement”) is made as of April 1, 2020, between Metropolitan Capital Advisors Ltd. a Texas limited partnership, with an address at 3131 Turtle Creek Boulevard, Suite 1200 Dallas, TX 75219, (the “Assignor”) and Marcus & Millichap Capital Corporation, a California corporation with an address at 23975 Park Sorrento, Suit 400 (“Assignee”).

WHEREAS, Assignors are the owners of all right, title and interest in and to the trademarks and service marks listed on the attached Schedule A, the United States Patent and Trademark Office (“USPTO”) applications for registration therefor, and the common law rights therein (collectively, the “Marks”), together with the goodwill of the business developed through the use of the Marks;

WHEREAS, Assignee is desirous of acquiring all of Assignors’ rights in the Marks, together with the goodwill of the business symbolized thereby;

NOW, THEREFORE, for one dollar and other good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the parties agree as follows:

1. Assignors hereby assign and transfer to Assignee, their entire worldwide right, title, interest in and to the Marks, and the goodwill of the business associated with the Marks, including the right to sue for and receive all damages for any past and future infringements of the Marks, the same to be held and enjoyed by Assignee, its successors and assigns.
2. This Agreement may be recorded by Assignee in its sole discretion as it deems appropriate with the USPTO or any other government trademark office in the world, without further notice to Assignors.
3. Assignors agree that they will execute such documentation as may be reasonably necessary in the future to effectuate the intent of this Agreement.
4. This Agreement shall be governed, interpreted and enforced by the laws of the State of Delaware, without regard to its conflicts of law policies.
5. This Agreement may be executed in counterparts, including by electronic and digital means, each of which shall be deemed an original but both of which together shall constitute one and the same instrument.


