Such instruments and documents shall include, without limitation, affidavits, including affidavits of use, and other documents for filing in such jurisdictions as the Assignee may from time to time reasonably request.

The Assignor hereby represents and warrants that there are no rights and interests outstanding inconsistent with the rights and interests granted herein and that the Assignor

will not execute any instrument or grant or transfer any rights or interests inconsistent herewith.

AND it is further covenanted and agreed that Assignor will, at any time upon request, communicate to said Assignee, its successors, assigns or other legal representatives, any facts relating to said Mark and the history thereof known to said Assignor and testify as to the same in any legal proceeding when requested to do so, sign all lawful papers, execute an necessary assignment papers to cause any trademarks to be issued to Assignee, make all rightful oaths and generally do everything necessary or desirable to aid said Assignee, its successors and assigns, to obtain, perfect title in and enforce proper protection for said Mark in the United States and in ant and all foreign countries.
