

TRADE MARK AND DOMAIN NAME ASSIGNMENT

This agreement is dated

July 22, 2020

PARTIES

- (1) **SPORTSDIRECT.COM RETAIL LIMITED** incorporated and registered in England and Wales with company number 03406347 whose registered office is at Unit A, Brook Park East, Shirebrook, NG20 8RY;
- (2) GAME RETAIL LIMITED incorporated and registered in England and Wales with company number 07837246 whose registered office is at Unity House, Telford Road, Basingstoke, Hampshire, RG21 6YJ;

(together the "Assignors")

(3) **BELONG GAMING LLC** incorporated and registered in the State of Delaware, the United States of America whose principal place of business is at 535 Madison Avenue, New York, NY, 10022 (the "Assignee")

BACKGROUND

- (A) The Assignors own the Registered Domain Names and the Trade Marks (as defined below).
- (B) By an APA (as defined below) of even date, the Assignors have agreed to assign to the Assignee the Assigned Rights (as defined below) on the terms set out in this agreement.

AGREED TERMS

1. INTERPRETATION

The following definitions and rules of interpretation apply in this agreement.

1.1 Definitions:

APA means the asset purchase agreement between the Assignors, the Assignee and Vindex LLC of even date, pursuant to which it has been agreed that the Assigned Rights shall be assigned to the Assignee under this agreement.

Assigned Rights means the Trade Marks and the Registered Doman Names.

BLA means the brand licence agreement between GAME Retail Limited, the Assignee and Vindex LLC of even date, pursuant to which it has been agreed that the Assignee licences to GAME Retail Limited certain rights to enable GAME Retail Limited to continue its use of certain of the Assigned Rights and Intellectual Property Rights associated therewith.

Business Day means day other than a Saturday, Sunday or public holiday in England when banks in London are open for business.

Intellectual Property Rights means any and all patents, utility models, rights to inventions, copyright and neighbouring and related rights, moral rights, trademarks and service marks, business names and domain names, rights in get-up and trade dress, goodwill and the right to sue for passing off or unfair competition, rights in designs, rights in computer software, database rights, rights to use, and protect the confidentiality of, confidential information (including know-how and trade secrets), and all other intellectual property rights, in each case whether registered or unregistered and including all applications and rights to apply for and be granted, renewals or extensions of, and rights to claim priority from, such rights and all similar or equivalent rights or forms of protection which subsist or will subsist now or in the future in any part of the world.

Registered Domain Names means the registered domain names set out in Schedule 2.

Trade Marks the registered trade marks and the applications set out in Schedule 1.

- 1.2 Clause, Schedule and paragraph headings shall not affect the interpretation of this agreement.
- 1.3 A **person** includes a natural person, corporate or unincorporated body (whether or not having separate legal personality).
- 1.4 The Schedules form part of this agreement and shall have effect as if set out in full in the body of this agreement. Any reference to this agreement includes the Schedules.
- 1.5 References to clauses and Schedules are to the clauses and Schedules of this agreement.
- 1.6 Unless the context otherwise requires, words in the singular shall include the plural and in the plural shall include the singular.
- 1.7 Unless the context otherwise requires, a reference to one gender shall include a reference to the other genders.
- 1.8 A reference to writing or written includes fax but not email.
- 1.9 Any words following the terms **including**, **include**, **in particular**, **for example** or any similar expression shall be construed as illustrative and shall not limit the sense of the words, description, definition, phrase or term preceding those terms.

2. ASSIGNMENT

Pursuant to and for the consideration set out in the APA, and subject to the terms of the BLA, the Assignors hereby assign to the Assignee absolutely all their rights, title and interests in and to the Assigned Rights, including:

- (a) the absolute entitlement to any registrations granted pursuant to any of the applications comprised in the Trade Marks;
- (b) the right to claim priority from any of the Trade Marks;
- (c) all goodwill attaching to the Trade Marks; and
- (d) the right to bring, make, oppose, defend, appeal proceedings, claims or actions and obtain relief (and to retain any damages recovered) in respect of any infringement, or any other cause of action arising from ownership, of any of the Assigned Rights whether occurring before, on, or after the date of this agreement.

For the avoidance of any doubt, the Assignors give no assurances as to (i) whether the Assignee will be registered as the holder of any Trade Mark which is the subject of a pending application; or (ii) (without prejudice to the rights and remedies of the Assignee under section 2.7.1 of the APA, and the corresponding provisions of the APA

required for the proper interpretation and application of section 2.7.1, including section 5.3) whether the Assignee is free to use any of the Trade Marks including (without limitation) those which are the subject of applications.

3. FURTHER ASSURANCE

At the Assignee's expense, each party shall, and shall use all reasonable endeavours to procure that any necessary third party shall, promptly execute such documents and perform such acts as may reasonably be required for the purpose of giving full effect to this agreement, including but not limited to:

- (a) registration of the Assignee as applicant for or registered proprietor of the Trade Marks; and
- (b) promptly completing all formalities (including the provision of all relevant account details and passwords) that are required to transfer full and unconditional ownership and technical control of the Registered Domain Names to, and to register the Registered Domain Names in the name of, the Assignee, including the change of registrant name and change of administrative contact as directed by the Assignee and, where required by the Assignee, change of registrar and webhost.

4. WAIVER

No failure or delay by a party to exercise any right or remedy provided under this agreement or by law shall constitute a waiver of that or any other right or remedy, nor shall it prevent or restrict the further exercise of that or any other right or remedy. No single or partial exercise of such right or remedy shall prevent or restrict the further exercise of that or any other right or remedy.

5. VARIATION

No variation of this agreement shall be effective unless it is in writing and signed by the parties (or their authorised representatives).

6. SEVERANCE

- 6.1 If any provision or part-provision of this agreement is or becomes invalid, illegal or unenforceable, it shall be deemed modified to the minimum extent necessary to make it valid, legal and enforceable. If such modification is not possible, the relevant provision or part-provision shall be deemed deleted. Any modification to or deletion of a provision or part-provision under this clause shall not affect the validity and enforceability of the rest of this agreement.
- 6.2 If any provision or part-provision of this agreement is invalid, illegal or unenforceable, the parties shall negotiate in good faith to amend such provision so that, as amended, it is legal, valid and enforceable, and, to the greatest extent possible, achieves the intended commercial result of the original provision.

7. COUNTERPARTS

7.1 This agreement may be executed in any number of counterparts, each of which when executed and delivered shall constitute a duplicate original, but all the counterparts shall together constitute the one agreement.

8. GOVERNING LAW AND JURISDICTION

This agreement, and any controversy or dispute arising in connection with this agreement, shall be governed by and construed in accordance with the substantive law of the State of New York. Each Party irrevocably submits to the sole and exclusive jurisdiction of the courts of New York State and the Federal courts of the Southern District of New York, situated in the City, County and State of New York. Each Party irrevocably consents to the exercise of personal jurisdiction over each of the Parties by such courts and waives any right to plead, claim or allege that

New York is an inconvenient forum. Each Party irrevocably waives, to the fullest extent permitted by applicable law, any and all right to trial by jury in any legal proceeding arising out of or relating to this agreement.

This agreement has been entered into on the date stated at the beginning of it.
