**RELEASE OF SECURITY INTEREST IN  
TRADEMARK COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL** (this "Release") is dated as of July 29, 2020 by BANK OF AMERICA, N.A., as collateral agent (in such capacity, the "Collateral Agent"), in favor of VACASA LLC (the "Owner").

**W I T N E S S E T H**

WHEREAS, Wyndham Destinations, Inc. (the "Borrower") and the Collateral Agent entered into the Credit Agreement dated as of May 31, 2018 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), each L/C Issuer and each Lender from time to time party thereto.

WHEREAS, pursuant to the Security Agreement, the Borrower executed and delivered to the Collateral Agent that certain Intellectual Property Security Agreement dated as of May 31, 2018 (the "Trademark Security Agreement") and recorded with the United States Patent and Trademark Office ("USPTO") on June 5, 2018 at Reel/Frame No. 6344/0620, pursuant to which the Grantor assigned, pledged and granted to the Collateral Agent, its successors and assigns, for the benefit of the Secured Parties (as defined in the Security Agreement), a security interest in all right, title and interest in or to any and all of the Trademark Collateral (as defined in the Trademark Security Agreement); and

WHEREAS, pursuant to the Trademark Assignments (Nunc Pro Tunc), each effective on or about October 22, 2019 and recorded with the United States Patent and Trademark Office ("USPTO") on March 5, 2020 at Reel/Frame No. 6884/0117 and on March 6, 2020 at Reel/Frame Nos. 6884/0217, 6884/0221, 6884/0224 and 6884/0260, pursuant to which the ASSIGNOR assigned unto ASSIGNEE nunc pro tunc all right, title and interest in and to the trademark, including the Marks and Registrations, together with the good will of the business associated with the Marks;

WHEREAS, in connection with the sale by Wyndham Destinations Network, LLC of all of the Equity Interests of (1) Wyndham Vacation Rentals North America, LLC, a Delaware limited liability company and a Restricted Subsidiary (the "Company") and (2) the Company's wholly-owned direct and indirect subsidiaries, to Vacasa LLC, a Delaware limited liability company, the Borrower has requested that the Collateral Agent release, and the Collateral Agent desires to release, its security interest in all right, title and interest in and to the Trademark Collateral.]

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the Collateral Agent hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, its security interest in all right,

title and interest in or to any and all of the Trademark Collateral, including the trademark registrations and trademark applications set forth in Schedule I attached hereto and incorporated herein by reference, and agrees that the security interest in the Trademark Collateral is hereby discharged, terminated and released. The undersigned hereby transfers and assigns to the Grantor, without recourse, representation or warranty, any and all right, title and interest that the Collateral Agent may have obtained in, to and under the Trademark Collateral under the Security Agreement or the Trademark Security Agreement and agrees, at Grantor's sole cost and expense, to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release contemplated hereby.


