**CERTIFICATE OF AMENDMENT OF THE  
AMENDED AND RESTATED CERTIFICATE OF INCORPORATION**

eyeBrain Medical, Inc. (the "*Company*"), a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware, certifies that:

1. The name of the Company is eyeBrain Medical, Inc. The Company's original Certificate of Incorporation was first filed with the Secretary of State of the State of Delaware on May 17, 2012 under the name Yelroc Neuro, Inc. (the "*Certificate of Incorporation*").

2. Pursuant to Section 242 of the General Corporation Law of the State of Delaware, this Certificate of Amendment (this "*Certificate of Amendment*") amends the provisions of the Corporation's Certificate of Incorporation.

3. This Certificate of Amendment was duly adopted in accordance with Sections 242 of the General Corporation Law of the State of Delaware and has been duly approved by the written consent of the stockholders of the Corporation in accordance with Section 228 of the General Corporation Law of the State of Delaware.

4. Article I of the Certificate of Incorporation of the Corporation is hereby amended and restated to read in its entirety as follows:

"The name of the corporation is Neurolens, Inc. (the "*Company*")."

5. This amendment was duly adopted in accordance with the provisions of Section 242 of the Delaware General Corporation Law.
