**DECLARATION REGARDING RELEASE OF
SECURITY INTERESTS IN TRADEMARKS**

4. Pursuant to the terms and conditions of that certain trademark security agreement recorded with the United States Patent and Trademark Office on July 27, 2005, at reel/frame 3129/0001, the Company granted security interests in the Applicable Trademarks (the "3129/0001 Security Interests"), in favor of Wells Fargo Bank Northwest, National Association, F/B/O Goldman Sachs Credit Partners L.P. (the "3129/0001 Secured Party");
5. Pursuant to the terms and conditions of that certain trademark security agreement recorded with the United States Patent and Trademark Office on July 27, 2005, at reel/frame 3129/0025, the Company granted security interests in the Applicable Trademarks (the "3129/0025 Security Interests"), in favor of Wells Fargo Bank, National Association, F/B/O Pari Existing Shareholder Noteholders (the "3129/0025 Secured Party");
6. Pursuant to the terms and conditions of that certain trademark security agreement recorded with the United States Patent and Trademark Office August 3, 2005, at reel/frame 3133/0809, the Company granted security interests in the Applicable Trademarks (the "3133/0809 Security Interests"), in favor of Wells Fargo Bank Northwest, National Association, F/B/O Noteholders (the "3133/0809 Secured Party");
7. Pursuant to the terms and conditions of that certain trademark security agreement recorded with the United States Patent and Trademark Office on August 3, 2005, at reel/frame 3133/0787, the Company granted security interests in the Applicable Trademarks (the "3133/0787 Security Interests" and, together with the 3128/0992 Security Interests, 3129/0001 Security Interests, 3129/0025 Security Interests and 3133/0809 Security Interests, the "Security Interests"), in favor of Wells Fargo Bank Northwest, National Association, F/B/O Pari Existing Shareholder Noteholders (the "3133/0787 Secured Party" and, together with the 3128/0992 Secured Party, 3129/0001

Secured Party, 3129/0025 Secured Party and 3133/0809 Secured Party, each, a "Secured Party").

8. The Company's obligations under the agreements pursuant to which the Security Interests were granted have been fully satisfied and terminated in or about May 2011, and there are no remaining obligations owed to the Secured Parties or any successors-in-interest thereto;

The Company has made or caused to be made a diligent effort to obtain documentary evidence of the releases of the Security Interests from the Secured Parties and, despite the failure to obtain such documentation, it is a fact that the underlying Security Interests of the Secured Parties have been terminated and released by the Secured Parties; and
10. I have personal knowledge of the facts set forth above and all such statements are true.
