TRADEMARK ASSIGNMENT

This Trademark Assignment (the "Assignment") is made effective as of August 14, 2020 (the "Effective Date"), by Extra Storage Space LLC, a Delaware corporation having an address of 2795 E. Cottonwood Plaza, Suite 400, Salt Lake City, Utah 84121 ("Assignor"), in favor of U.S. Storage Search, Inc., a Nebraska corporation having an address of 19700 North 76th Street, Suite 2079, Scottsdale, Arizona 85255 ("Assignee").

RECITALS

WHEREAS, on January 1, 2018, Assignor's related entity, Self Storage Company, LLC, and Assignee executed the Domain Name Purchase and Transfer Agreement pursuant to which Self Storage Company, LLC conveyed, transferred and assigned to Assignee certain internet domain names, including the STORAGE.COM domain name;

WHEREAS, in conjunction with the Domain Name Purchase and Transfer Agreement, Assignor has agreed to execute and deliver this Trademark Assignment for recording with governmental authorities including the U.S. Patent and Trademark Office;

NOW, THEREFORE, in consideration of the foregoing introduction and recitals and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. Assignor does hereby irrevocably sell, assign, transfer and set over to Assignee, and Assignee hereby accepts, all of Assignor's right, title, and interest in and to the following (the "Assigned Trademark Rights")
 - a. All rights that Assignor has obtained through use of any of the marks identified on Exhibit A, including the goodwill of the business in which the marks are used (the "Assigned Marks");
 - b. Each trademark registration and application set forth on Exhibit A, any resulting registrations, and all rights associated with the filing of a trademark application, including the right to claim priority under the Paris Convention (the "Assigned Trademark Applications and Registrations");
 - c. All royalties, fees, income, payments, and other proceeds now or hereafter due or payable with respect to any of the Assigned Marks or the Assigned Trademark Applications and Registrations; and
 - d. All claims and causes of action related to any of the Assigned Marks or the Assigned Trademark Applications and Registrations, whether accruing before, on, or after the Effective Date, including, without limitation, all rights to and claims for damages, restitution and injunctive and other legal and equitable relief for past, present, and future infringement, dilution, misappropriation, violation, misuse, breach or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.
2. In the event Assignee fails to complete all payments required by the Domain Name Purchase and Transfer Agreement, and as a result of such failure, the ownership of

the STORAGE.COM domain name returns to Self Storage Company, LLC, Assignee hereby agrees to execute an assignment agreement to transfer ownership of the Assigned Trademark Rights back to Assignor.

3. Assignor hereby authorizes the Commissioner for Trademarks in the United States Patent and Trademark Office and the officials of corresponding entities or agencies in any applicable jurisdiction to record and register this Trademark Assignment upon request by Assignee. Upon Assignee's reasonable request, Assignor shall take such steps and actions, and provide such cooperation and assistance to Assignee and its successors, assigns and legal representatives, including, without limitation, the execution and delivery of any affidavits, declarations, oaths, exhibits, assignments, powers of attorney, or other documents, as may be necessary to effect, evidence or perfect the assignment of the Assigned Trademark Rights to Assignee, or any assignee or successor thereto.
4. This Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed the same agreement. A signed copy of this Trademark Assignment delivered by facsimile, e-mail, or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Trademark Assignment.
5. This Trademark Assignment shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns.
6. This Assignment is deemed to be executed and delivered within the State of Nebraska, and it is the intention of the parties that it shall be construed, interpreted and applied in accordance with the laws of the State of Nebraska without regard to its conflicts of law principles.

IN WITNESS WHEREOF, Assignor and Assignee have duly executed this Assignment as of the Effective Date.


