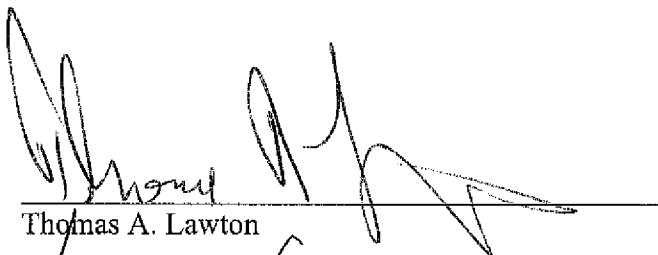

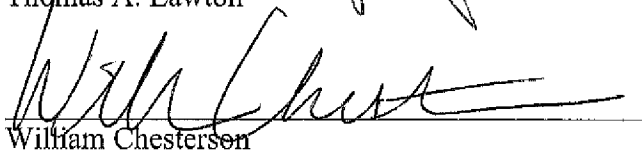
section of the minute book of the Corporation and that the Corporation proceed to do business thereunder.
