STATE OF GEORGIA CERTIFICATE OF CONVERSION

(Pursuant to Section 14-11-906 of the Georgia Business Corporation Code)

1. The name of the converting Georgia limited liability company is Revolution Gelatos LLC (the "*Converting Entity*").
2. The Converting Entity elects to become a Delaware corporation under the name Revolution Gelato, Inc. (the "*Resulting Entity*").
3. The conversion shall become effective upon the filing of this Certificate of Conversion with the Georgia Secretary of State (the "Effective Time").

7. The Georgia Secretary of State shall be notified of any change in the Resulting Entity's mailing address set forth in paragraph (6) above.
