PARTIAL RELEASE OF TRADEMARK SHORT FORM SECURITY AGREEMENT

This Partial Release of Trademark Short Form Security Agreement (this “Release”) is made as of September 21, 2020, by CORTLAND CAPITAL MARKET SERVICES LLC, in its capacity as Collateral Agent for the Lenders under (and as defined in) the Security Agreement referred to below (the “Collateral Agent”) for the benefit of AF GLOENCO INC., a Delaware corporation (the “Grantor”). Capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the Security Agreement.

WITNESSETH:

WHEREAS, the Grantor and the Collateral Agent are parties to that certain (i) Security Agreement, dated as of June 8, 2017 (as amended, restated or otherwise modified through the date hereof, the “Security Agreement”) among AFG HOLDINGS, INC. (f/k/a FR AFG HOLDINGS, INC.), a Delaware corporation, AMERIFORGE GROUP INC., a Texas corporation (the “Borrower”), the subsidiaries of the Borrower from time to time party thereto and the Collateral Agent; and (ii) Trademark Short Form Security Agreement, dated as of June 8, 2017 (as amended, restated or otherwise modified through the date hereof, the “Short Form Trademark Security Agreement”), pursuant to which the Grantor has granted to the Collateral Agent for the benefit of the Secured Parties a lien on and security interest in, among other things, all of the right, title and interest of the Grantor in and to (i) the trademark set forth on Schedule I hereto (the “Subject Trademark”), (ii) all goodwill associated with or symbolized by the Subject Trademark, and (iii) all Proceeds and products of the Subject Trademark (clauses (i) through (iii) hereof collectively, the “Released Property”);

WHEREAS, the Short Form Trademark Security Agreement was recorded in the United States Patent and Trademark Office on June 8, 2017 at Reel 006079 and Frame 0613; and

WHEREAS, Grantor has requested that the Collateral Agent release, and the Collateral Agent is willing to release its lien on and security interest in, and any other right, title, and interest it may have in, to and under the Released Property (but not in any other Collateral).

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agrees as follows:

1. The Collateral Agent does hereby terminate, release and discharge the entirety of any and all liens or security interests that it may have, and all claims, whether presently existing or hereafter acquired or created, pursuant to the Security Agreement or Short Form Trademark Security Agreement in and to the Released Property (but not any other liens, security interests or claims granted under the Security Agreement or Short Form Trademark Security Agreement) and any right, title or interest of the Collateral Agent in such Released Property (but not in any other Collateral) shall hereby terminate, cease and become void. The Collateral Agent hereby assigns, transfers and conveys any and all right, title or interest of the Collateral Agent in the Released Property (but not in any other Collateral) to the Grantor.

2. It is expressly understood and agreed that this is a partial release and shall in no way release, affect or impair the undersigned's rights, titles, interests and liens against any other interest and property described in and covered by the Security Agreement or Short Form Trademark Security Agreement.


3. This Release may be executed in any number of counterparts (including electronic transmission and facsimile counterparts), each of which when so executed and delivered shall be deemed an original, but all such counterparts together shall constitute but one and the same instrument.

4. This Release and the rights and obligations of the parties hereunder shall be governed by, and shall be construed and enforced in accordance with, the laws of the State of New York.
