## TRADEMARK ASSIGNMENT

**THIS TRADEMARK ASSIGNMENT** (this "**Trademark Assignment**") is made by and between **TMAFS, LLC**, a North Carolina limited liability company, located at 346 9th Street SE, Hickory, North Carolina 28602 ("**Assignor**"), and **JOSEPH D. OSBORNE**, an individual residing at 346 9th Street SE, Hickory, North Carolina 28602 ("**Assignee**"), individually referred to as a "**Party**" or collectively as the "**Parties.**"

### **RECITALS**

**WHEREAS** as of October 1, 2020 the Parties entered into that certain Assignment Agreement (the "**Assignment Agreement**"), which conveyed the entire right to U.S. Trademark Registration No. 4,935,624 for The Next Bug Thing (the "**Mark**"); and

**WHEREAS** the Parties wish to enter into this Trademark Assignment for the sole purpose of confirming and memorializing some of the terms of the Assignment Agreement that are not confidential, proprietary and/or trade secrets of either Party, and making said terms of record in the U.S. Patent and Trademark Office;

### **TERMS AND CONDITIONS**

**NOW, THEREFORE**, pursuant to the Assignment Agreement and in consideration of the mutual premises and covenants contained therein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereto, intending to be legally bound, hereby agree as follows:

Assignor shall irrevocably assign, set over, transfer, convey, and deliver, and does hereby irrevocably assign, set over, transfer, convey, and deliver to Assignee all right, title, and interest in, to, and under the Mark, and any applications or registrations therefor, together with the goodwill of the business in connection with which the Mark is used and which are symbolized by the Mark, including, but not limited to, the use of the Mark in any manner, and Assignor does hereby further assign, sell, transfer and convey unto Assignee any and all claims of Assignor for past, current, and future infringement and any and all causes of action of Assignor with respect to or arising out of the Mark, along with the right to recover damages and profits for past, current, and future infringements thereof.


