**TERMINATION AND RELEASE OF  
SECOND LIEN SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Second Lien Security Interest in Trademarks (“Release”) is made as of October 16, 2020, by **CREDIT SUISSE AG, CAYMAN ISLANDS BRANCH**, a Switzerland bank (“Administrative Agent”) in favor of **CENTRAL SECURITY GROUP – NATIONWIDE, INC.**, a Delaware corporation with an address at 2448 East 81<sup>st</sup> Street, Suite 4300, Tulsa, Oklahoma 74137 (the “Grantor”).

W I T N E S S E T H:

WHEREAS, the Grantor entered into a certain trademark security agreement dated October 6, 2014 (the “Trademark Security Agreement”) with Administrative Agent, notice of which was recorded on October 6, 2014 at the United States Patent and Trademark Office at Reel 5375, Frame 0831.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, Grantor granted the Administrative Agent, under the terms of the Trademark Security Agreement, a security interest (the “Security Interest”) in favor of the Administrative Agent, in all of its right, title and interest in or to all of the Owned Trademarks included in the Collateral, including without limitation the trademarks listed in Schedule A attached hereto (collectively, the “Trademark Collateral”).

WHEREAS, the Administrative Agent has agreed to terminate and release its security interest in all such Trademark Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Administrative Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates and discharges any and all of its interest in the Trademark Collateral of the Grantor, and assigns, transfers and conveys to Grantor any interest in such Trademark Collateral.
