**RELEASE OF TRADEMARK SECURITY INTEREST  
(BAW, Inc. and BN Ranch, LLC)**

This Release of Trademark Security Interest (this “Release”), dated as of October 16, 2020, is made by MORGAN STANLEY SENIOR FUNDING, INC., as collateral agent for the Secured Parties (as defined in the Security Agreement referred to below) (in such capacity, the “Collateral Agent”), in favor of BAW, INC., a Delaware corporation and BN RANCH, LLC, a Delaware limited liability company (each a “Grantor” and collectively, the “Grantors”). Capitalized terms used but not otherwise defined herein shall have the meanings ascribed to those terms in the Trademark Security Agreement (as defined below).

WHEREAS, the Grantors became a party to that certain Pledge and Security Agreement, dated as of August 26, 2016 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”), by and among the OBLIGORS party thereto and the Collateral Agent;

WHEREAS, pursuant to the Security Agreement, the Grantors executed and delivered a Trademark Security Agreement dated as of October 9, 2018, in favor of the Collateral Agent (as amended, amended and restated, supplemented or otherwise modified from time to time, the “Trademark Security Agreement”), which was recorded in the U.S. Patent and Trademark Office on October 10, 2018, at Reel/Frame 6454/0078;

WHEREAS, pursuant to the Trademark Security Agreement, each Grantor pledged and granted to the Collateral Agent, for its benefit and for the benefit of the Secured Parties, a continuing security interest and Lien on (the “Security Interest”) all of its right, title, and interest in, to and under all Trademark Collateral, including the trademark registrations and applications set forth on Schedule A hereto (collectively, the “Released Collateral”); and

WHEREAS, pursuant to the terms and conditions set forth in the Security Agreement and the Trademark Security Agreement and relying upon the representations, warranties and certifications made by the Grantors, the Collateral Agent has agreed to release its security interest in the Released Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantors and the Collateral Agent hereby agree as follows:

Section 1. Release of Security Interest. The Collateral Agent hereby, without any representation, warranty or recourse, releases and discharges its Security Interest in the Released Collateral. The Collateral Agent authorizes the recordation of this Release with the U.S. Patent and Trademark Office.

Section 2. Termination. The Collateral Agent, without any recourse, representation or warranty, hereby terminates and cancels the Trademark Security Agreement.

Section 3. Governing Law. THIS RELEASE AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HEREUNDER SHALL BE GOVERNED BY, AND CONSTRUED AND ENFORCED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK, WITHOUT REGARD TO CONFLICT OF LAW PRINCIPLES THAT WOULD RESULT IN THE APPLICATION OF ANY LAW OTHER THAN THE LAW OF THE STATE OF NEW YORK.

Section 4. Signatures. Delivery of an executed signature page of this Release by facsimile or electronic transmission shall be effective as delivery of a manually executed counterpart hereof.


